Finally, some good news is coming for our 4-H activities and events for this summer!

We do first need to get through June, where our Level A will continue. This means that we will continue the no face-to-face policy. All activities, events, club meetings, etc. will continue to be virtual for the month of June.

Beginning July 1, we will begin to transition to Level B, but in multiple phases. Under the first portion of Level B, we would still prefer that events take place virtually when possible, but we will be able to begin some activities of 15 people or less. All participants must maintain physical distancing of at least 6 feet whether indoors or out. The wearing of masks will also be required.

Beginning August 1, we will move to the next phase of Level B, which will open our activities and events to 50 people or less. There may still be activities that take place virtually. The physical distancing and mask requirements will still be in effect.

It should be noted that these protocols are passed down from SDSU and have been carefully prepared for the safety and well-being of employees, guests, and the public that we interact with. They were written with guidance from SDSU, the Centers for Disease Control (CDC), and the South Dakota Department of Health.

Decisions for movement into more or less restrictive plan phases will depend on the trend direction of local data including hospitalization rates, level of community spread, or the emergence of a local hot spot. We will still need to continue to follow the policy of SDSU Extension, but this means that restrictions are subject to change based on local needs.

Please remember that we are not yet in a position to be moving back to the way things were before March 15th. Please be patient and understanding as we work through these changes.

We are excited to start working toward “normal” and to be able to start seeing all of you in person!

2020 State 4-H Event Cancellation Calendar

A transparent list of cancellation decision deadlines in light of the COVID-19 pandemic

First edition; last updated June, 2, 2020

Introduction

This list aids planning and decision-making for 4-H member families and volunteers in light of the ongoing COVID-19 pandemic. Its purpose is to communicate transparently the last possible date we will decide to keep a particular state 4-H event. Given the significant lead-time needed to prepare for and conduct our events, we hope this list will give you a better picture for how the upcoming 4-H season may transpire.

How it works

By way of example, consider the Healthy Living Day Camps (HLDC) slated for the second week of July. In order to properly prepare and conduct the HLDC, we have set our cancel decision date as May 22. So, imagine a scenario in which the 4-H in-person activity ban was lifted (by the Governor's office, University, Extension, etc.) on June 1. Under that circumstance, the HLDC would remain cancelled even though it might *seem* like they should have been able to continue.

Summer 2020 Letter to 4-H Families

Dear South Dakota 4-H Families,

Are we done yet? Yeah, I understand that feeling. Quarantine helps us to re-set priorities and value relationships anew, but there is a reason we craft our lives a certain way. Selfishly, I am looking forward to that first trip to the ice cream stand or watching a live event! May 'normal' find us more quickly than we expect, and may we make good choices in the meantime.

Until today, you have not heard directly from me. In the first two months of the COVID-19 quarantine era, we maintained our normal county-based communications mode because the most immediate 4-H concerns were local. As the summer approaches, we pivot to the time when state events take on more importance; thus, today's message is provided centrally. Lines--to aid reading accessibility--separate different topics contained within this message. Please read carefully.

First, I want to celebrate the 4-H spirit exhibited by so many of you these past several weeks! Stories of individual 4-Hers safely volunteering to serve first responders, make cloth masks, and deliver food are an inspiration. Volunteers rallied to try new engagement methods. Professionals designed new virtual and curbside-to-go program opportunities. Teens adapted their upcoming leadership conference to provide an innovative virtual experience. Many have learned the new skill of avoiding the "double-chin look" while participating in online 4-H club and committee meetings. ☺ Thank you all for diving in with 4-H spirit to self-care while serving others.

Second, I want to share an exciting announcement about our virtual summer 4-H plans. To move us beyond the sadness of missing our favorite summer activities, a task force of 4-H professionals from across the state designed the amazing *South Dakota Summer Adventures* series. Featuring different topic themes each week, this 11-week series includes fun online and try-at-home lessons, creative hands-on contests, and weekend family challenges. Thanks to the generous leadership gift of the State 4-H Leaders Association and many supporting county associations, over \$10,000 in prizes* will be awarded! This is an incredible opportunity to invite non 4-H friends whose summer plans have been changed by cancelled camps, sports, and work opportunities. So join in this fun series and invite others as well! Third, let's discuss the elephant in the room. Even with our exciting summer series, everyone wants to know: when do we get to re-start in-person 4-H again? Are we going to have a state fair? Because I cannot answer those questions with accuracy, let me do a little show and tell instead. At the bottom of the page you will see a chart. This chart showcases the SD4-H phases of re-entry toward in-person activities. As of today, here is where we stand:

- SD4-H remains in Level A until at least May 31.
- Should we migrate to Level B--which might open up a few size-limited opportunities like club meetings or shooting sports practices--that status change will be communicated to you via local 4-H professionals. Please give them time for any local event adaptations to be prepared. Be patient, this is not a time for comparing with neighboring counties.
- SDSU has announced that we will not be at Level C until at least mid-August. Events such as Finals Rodeo, State Dog Show, State Horse Show, State Fair, etc. continue to be planned as if a modified, in-person experience will occur. *Special Note #1: Level C is not the same as "normal;" it is very unlikely that any 2020 events will occur without modifications. Special Note #2: local event participation has been waived as a requirement for state event participation.*

Risk Level Chart

The chart below corresponds with the three risk levels. *Level A* corresponds with the lowest risk approach where quarantine is the norm. *Level B* corresponds with a lower risk approach where quarantine is lifted but group size remains significantly limited. *Level C* corresponds with a low risk approach where public events are allowed but good hygiene practices still determine event operations and modifications. Chart view:

Note: this chart indicates the *maximum* allowable forms of participation; counties may always choose less in accordance with local needs/options. In areas facing a short-term “hot spot” for COVID-19 spread, local 4-H professionals may choose a more risk averse pathway in the interest of public safety; however, they may *not* choose a riskier pathway than what SDSU/SD4-H currently allows.

Why can't 4-H return to “normal” as quickly as some local communities?

As of mid-May 2020, the federal and state COVID-19 responses lean heavily on local decision-making and personal responsibility. Local decision-makers consider a range of factors, but primarily they try to balance economics and public safety. Though they acknowledge the best thing to do for public safety is remain in quarantine mode, they are unable to look beyond the negative impacts to the local economy. *Public universities do not have that decision-making flexibility*; they are governed by statutes that require student safety as the highest priority. This safety-first requirement will produce long-term fiscal consequences for public universities nationwide.


The 4-H program in each state is entrusted by statute to its land-grant public university (e.g., SDSU in South Dakota). As a result, the 4-H program folds into many of the same statutes that govern student safety in public higher education. Thus, we must make decisions from an evidence-based safety framework. During normal times this framework makes 4-H a highly valued and trusted institution for parents, businesses, and community leaders. During the current era, this framework is a tougher pill to swallow in a state that places a high value on independence and personal responsibility. Though we understand the frustration, the safety-first framework will not change.

Please do not ask your local 4-H professionals or leaders to “break ranks” and go forward with events against SDSU timelines. These standards exist to protect our members, families, volunteers, and unknown vulnerable others. It is an excellent and difficult lesson in citizenship.

Finally, I wish you well in the culmination of the 2020 4-H season! Try alternative learning methods. Take advantage of newfound time to give more depth to your 4-H project areas of interest--even if an awards ribbon or trip to nationals is no longer available. Wash the dishes without being asked. Mow the yard for your elderly neighbor. Appreciate the formation of resiliency skills that will last a lifetime.

Thank you for demonstrating the 4-H spirit of #inspiredtodo in all circumstances. I wish you all the best health in the months ahead.

*Contest prizes are a little higher than our normal 4-H award practices because we recognize that many youth will miss out on traditional income sources this summer, making the prizes uniquely beneficial. Appropriate individual limits will be in place. Importantly, the long-held 4-H philosophy that “we do not pursue activities for the awards” remains unchanged.

COVID-19 UPDATE

2020 South Dakota 4-H Animal Project Required Documents

Updated as of May 15, 2020

All deadlines and information in this document supersede any previous guidance. These changes are for the 2020 season only and do not set a precedent for future 4-H seasons.

All

- County Event Qualifying
 - Many local 4-H horse, livestock, etc. shows (Achievement Days) will be cancelled this summer. As a result, the local qualifying requirement is universally waived. If the equivalent state event occurs (we hope!), you will be eligible to participate at the state event as long as the other applicable form, tag, enrollment, etc. deadlines have been met.

Horse

- Horse Identification Form
 - Horse Identification Form will not be required to be uploaded into 4HOnline this year since the animal identification is entered into 4HOnline.
 - Animal identification is still required to be entered into 4HOnline by June 1st at 11:59 p.m.
- Achievement Form
 - Training is still required but the form does NOT need to be signed by a 4-H volunteer or professional. In its place it is up to each project leader to keep track of which participants have submitted their training summary paragraphs, quizzes, and or skills videos. The project leaders will then communicate with the County Extension Office to verify that all participants have completed the requirements.
 - Family uploads to 4HOnline by normal deadline.
- Lease Form (same as livestock form)
 - The only signatures that will be required on this form are those of the 1) animal owner, and 2) the lessee and/or their family.
 - The lease form must be uploaded into 4HOnline by June 1st at 11:59 p.m.
- State Horse Show Registration
 - This deadline has been moved to **August 11 at 11:59 p.m.**, the same day as the other animal registration deadlines. Registration will take place in Fair Entry.
 - **New Date!** We are planning for a modified, in-person State Horse Show in Huron on August 29-30. Event details will be shared as the situation unfolds.
- Health Certificates
 - An up to date Health Certificate will still be required at the State Horse Show, this is a requirement of the Animal Industry Board.
- Horse Photo
 - A photo of your horse is still required to be uploaded into 4HOnline.

Dog

- Animal Identification
 - Animal identification is still required to be entered into 4HOnline by June 1st at 11:59 p.m.
- Proof of Vaccinations
 - It is now strongly recommended that proof of vaccinations be uploaded into 4HOnline by the first competition. It will also be required that a **paper copy** is brought to the State Dog Show.
- Dog Photo
 - A photo of your dog is still required to be uploaded to 4-H Online/Fair Entry.

Livestock

- Animal Identification
 - Animal identification is still required to be entered into 4HOnline by June 1st at 11:59 p.m.
- DNA
 - Due to the County Extension Office by **June 1st**.
 - Offices: Be sure to keep track of those envelopes that will need to be sent in for participants competing at ASKARBAN. This is for exhibitors wanting to show at both AKSARBEN and the 4-H Division of the South Dakota State Fair.
- NUES Tags
 - Are still required for The State Fair and the tag information is required to be uploaded to 4-H Online by **June 1st** at 11:59 PM.
- Lease Form
 - The only signatures that will be required on this form are those of the 1) animal owner, and 2) the lessee and/or their family.
 - The lease form must be uploaded into 4HOnline by June 1st at 11:59 p.m.
- Breed Registration
 - The new deadline to upload will be **August 11th** and we are requiring a **paper copy** be brought to the State Fair.
- YQCA Certification
 - SD4-H livestock producers are committed to providing safe, reliable food sources for local buyers. Annual YQCA certification is one small component of assuring a quality product for the consumer. Unfortunately, National YQCA's prohibition of modified instructional formats + our desire to reasonably reduce participant costs during an economic downturn + the consideration that few (if any) large-scale meatpackers will be processing 4-H animals this year = YQCA has been **reduced to a recommended activity** for the 2020 4-H season. To be clear, it is no longer required. Members in their first 3 years of 4-H livestock care are strongly encouraged (but not required) to complete the YQCA *online* course. No refunds or 2021 carry-forwards are available for those who already completed 2020 YQCA prior to the pandemic's disruption.
